- 1.0 President Sam Twedt Called the meeting to order.
- 2.0 President's Report: Sam Twedt gave a President's Report for the year.

 - 6.1 ND Red Select Sale – Scott Kueffler, Ryan Clemetson

Reported that outs will be charged \$90 per animal out. Sale Manager, Jeff Thomas gave a report on the 2022 ND Red Select Sale.

Discussion was held on black-red carriers being allowed in the sale. Annette Steffan moved that only Red Hided, category 1A or 1B animals be allowed in the ND Red Select Sale and that this be reflected in the bylaws. Kenny Forster second. The motion unanimously passed.
