## 5.2 **By-Laws Portfolio: Bryan Ressler & Annette Steffan**

- 5.2a The By-Laws were sent out to the membership for review. Comments below were stated or emailed at the NDRAA meeting held on July 25, 2023, at the ND State Fair.
  - -Corrections were made to distinguish voting member titles to be consistent with classes of membership.
  - -Emailed that only ND residents could hold an office. Don't think this would work because if someone pays dues, they are afforded full membership privileges and we can't discriminate against that.
  - -Terms of officers should be **3 years** and in conjunction with terms of directors. This will make the bookkeeping easier and the election cycle easier to keep track of. The other option would be to elect officers every year.
  - -Does the secretary/treasurer have the right to vote? It is an elected position and so the secretary has the right to vote. The stipend covers incidental expenses incurred by the secretary/treasurer.
  - -Concern over the amount of time the Secretary puts in...is it more than voluntary and should it be compensated more.

- -Article IV. Membership-Section 6: Voting-A. Each **Registered Membership** *and Honorary Lifetime Member*, whether and individual.....
- -Article IV. Membership-Section 6: Voting-B. Each *Registered Membership* and Honorary Lifetime member...
- -Article III. North Dakota Junior Red Angus Association. Add **Section 6. The NDRAA shall appoint and/or approve of the NDJRAA advisors.**
- 5.2b President Sam Twedt submitted the By-Laws on to the legal team at RAAA. The lawyer that will work on this specializes in By-Laws. Sam thought the approximate cost would be about \$3000. It was mentioned that NDRAA is being looked at as an example for other RAAA affiliates. Annette talked to the lawyer at the National Convention and asked that the By-Laws be submitted to us by November 1, 2023.
